## **1. INTRODUCTION**

The Institute of Human Behaviour and Allied Sciences (IHBAS) was established to comply with the directive of the Hon'ble Supreme Court in response to public interest litigation. The court observed that IHBAS should be an apex Institute similar to NIMHANS, Bengaluru. The Institute is an autonomous body registered under the Societies Act. The nature of the Institute has been outlined as modern, state of the art tertiary care centre and post graduate training Institute for Behavioural, Neuro and Allied Sciences.

The Institute utilizes a unique approach through its Clinical (Psychiatry, Neurology and Neurosurgery), Social (Clinical psychology, Psychiatric social work and Medical Anthropology) and Basic Sciences (Neurochemistry, Microbiology, Neuropsychopharmacology and Pathology) to ensure a truly comprehensive management of mental and neurological disorders.

In pursuance of its objectives the Institute has been involved in the following activities:

- Hospital and community based patient care services including preventive/ curative and rehabilitation services for the people of Delhi and neighboring states of north India.
- Post graduate teaching/training in Psychiatry, Neurology, Neurosurgery, Clinical Psychology, Psychiatric Social Work, Psychiatric Nursing and other related disciplines.
- Basic and applied inter-disciplinary research in Neuropsychiatry and Behavioural sciences.

The Hospital for Mental Diseases (HMD), Shahdara, was established in 1966 and converted into a multidisciplinary Institute under the Societies Act 1991. Since its inception in 1993, it has served as a good example of how judicial intervention can bring about changes for the benefit of the patients.

IHBAS uses a multidisciplinary approach towards preventive, curative and rehabilitative aspects of mental health and aspires to bring modern biological, physical and psychological knowledge combined with ancient wisdom of traditional systems of medicine through a psychosocial and socio-cultural approach under one roof. This integrated approach may help to unravel the myth of abnormal behaviour of human beings. One of the greatest achievements of this Institute in the

initial stage has been that more than 300 long stay patients who recovered and did not require any further hospitalization were successfully reintegrated into their families. Today, IHBAS has developed into a unique apex Institute using an integrated approach for the study of body, mind and behaviour.

The multidisciplinary approach reflects upon the three spheres of activities i.e., patient care (including community oriented services), research, and teaching & training. The clinical services in the areas of Mental Health, Neuro and Behavioural Sciences are supported by modern investigative procedures. Thus the advances in the basic science's research are integrated with the clinical services. This initiates both, new responsibilities and new perspectives in further development of scientific and clinical activities of the Institute.

Current activities of the Institute include:

- Treatment of psychiatric, neurological disorders and neurosurgical intervention,
- Regional resource centre for Northern and Western India under National Mental Health Programme (NMHP) and District Mental Health Programme (DMHP).
- A total of eight speciality clinics namely Child and Adolescent Clinic, Mental Retardation Clinic, Marital & Psychosexual Clinic, Tobacco Cessation Clinic, Neuro Behaviour Clinic, Drug Abuse Treatment and Rehabilitation Clinic, Movement Disorder Clinic, Neuro-palliative care, Epilepsy Clinic and Pain Relief Clinic & Pre-Anesthetic Checkup Clinic are run by the Institute covering specialized needs of patients with various disorders.
- Development of policies and programs related to mental health.
- Collection of epidemiological data on mental, behavioral and neurological disorders & development of Community oriented services.
- Research in the area of biological and psychosocial aspects of mental disorders; psychopharmacological aspects of alcohol abuse and drug dependence; vascular and degenerative disorders of central nervous system; application of newer psychopharmacological approaches in the treatment of neuropsychiatric disorders.
- Postgraduate training in Clinical Psychology, Psychiatry, Neurology, Psychiatric Nursing and other allied disciplines.

This Institute with multidisciplinary approach is growing with a mission to become a centre of excellence for delivery of patient care, teaching, training and research in the field of mental

health, behavioural and neurosciences by translating its given mandate and by developing a new vision.

There are seven supportive sections and one Yoga Centre.

- II. Medical store
- III. Physiotherapy

- V. Day care and vocational training centre

- VII. Library and documentation services

#### **PATIENT CARE AT IHBAS:**

IHBAS provides outpatients and inpatients care facility in Mental Health (Psychiatry, Clinical Psychology & Psychiatric Social Work), Neurology and Neurosurgery. IHBAS conducts regular speciality clinics to provide specialized services to patients with certain specific disorder or problems in the afternoon hours.

- (i) Child & Adolescent Mental Health Services/ Clinic: A weekly child and adolescent psychiatry clinic (CAPC) provides mental health care to the children and adolescents. The clinic held every Tuesday. In- patients facility is also available to this age group of patients.
- (ii) Mental Retardation Clinic: This clinic was setup in December 1999, to cater to the needs of persons with Mental Retardation on weekly basis with the help of a multidisciplinary team consisting of Psychiatrists, Clinical Psychologists and Psychiatric Social Workers. Special parent training programmes are also organized for parents of children with mental retardation. The clinic held every Tuesday.
- (iii) Marital & Psychosexual Clinic: This is a weekly speciality clinic, which provides specialized services to the patients suffering from psychosexual and marital problems. A joint team of psychiatrists and clinical psychologists is engaged in providing these services. The clinic is held every Monday. \
- (iv) Geriatric Mental Health Clinic This is a weekly speciality clinic, which provides specialized services to the elderly patients A joint team of psychiatrists, clinical

psychologists & PSWs is engaged in providing these services. The clinic is held every Monday.

(v) Neuro Behavioral Clinic: Services of this Clinic are available on every Friday afternoon with a provision of a joint team of Neurologists, Psychiatrists and Clinical Psychologists. Clinic provides services to the patients with behavioural disturbances associated with various medical and neurological illnesses.

(vi) Drug Abuse Treatment and Rehabilitation Clinic: This clinic is functional twice a week on Wednesday afternoon and offers service to the patients with problems of drug abuse and alcoholism. A multidisciplinary team of Psychiatrists, Clinical Psychologists and Psychiatric social workers is running the clinic. As for requirement the patients are admitted for four to six weeks for comprehensive indoor treatment. A multidisciplinary team consisting psychiatrist, clinical psychologists and psychiatric social workers is running the clinic.

(vii) Movement Disorder Clinic: The clinic held every Wednesday for patients with drug induced movement disorders like Parkinson's disease, Dystonia etc. Advanced treatment like botulinum toxin injections are given to the patients with focal dystonia.

(viii) Epilepsy Clinic: This clinic is run every Monday with an aim to treat but also provide knowledge about epilepsy to patients and their family members, through direct interaction and brochures. Support groups share their problems & experiences guided by social worker. Special attention is paid to women, children and chronic epilepsy patients who are refractory to treatment.

(ix) Emotional Health & Wellness Clinic: This clinic is run every Tuesday, Wednesday & Thursday afternoons with facility of direct registration for all.

(x) Neuro Palliative Care Clinic: This clinic is run every Wednesday Afternoon for elderly patients suffering with chronic neurological conditions.

#### **Inpatient Services:**

Inpatient services are available in Psychiatry, Neurology and Neurosurgery.

Ayush/Holistic Services at IHBAS:

- Homeopathy Clinic on Monday & Thursday
- Ayurvedic Clinic on Tuesday & Friday
- Unani Clinic on Wednesday & Saturday

#### **Community Outreach Services:**

Community outreach programmes have been initiated to take Neuropsychiatric care to the doorstep of the people. Simultaneously, this also aims to educate and create awareness in the public regarding these disorders and to eliminate the stigma and myths associated with mental illnesses. Encouraging response has been seen in the clinics located at Jahangirpuri, Dwarka, Chatarpur, Moti Nagar & Timarpur.

#### **Mobile Mental Health Unit (MMHU):**

Mobile Mental health services are provided to all 11 districts of Delhi for homeless & homebound patients by IHBAS. There are 11 teams with 11 patient transport vehicles for every district of Delhi.

#### **SAKSHAM (HWH/LSH)**

Two halfway homes/long stay homes were opened on 17/02/17 and named Saksham A for women and Saksham B for men. This is the first government run home in a hospital campus to ensure that these patients are not neglected. Latter formal inauguration done by Hon'ble Health minister (Govt. of NCT, Delhi) in presence of Secretary Health (Govt. of NCT, Delhi) and other dignitaries on 03.03.2017. These two Half Way Homes at IHBAS will be a model for other homes which would be evolving in different parts of Delhi.

### **1.1 PHILOSOPHY OF IHBAS**

The mentally ill person's sense of wellbeing and emotional equilibrium are disturbed. The various mental functions like thinking, emotions, memory, intelligence and decision-making etc. can be disturbed. Talk and behaviour can become abnormal. As a result the ability to work satisfactorily and lead normal life can be impaired, thus causing burden to the individual family and the society at large. Nursing care of such individual is a challenging task. Nurses need to develop empathetic understanding of the problems of the patient and their family members. Nursing care of such patients should be based on holistic approach with belief in psychosocial and rehabilitative foundations of nursing.

Indian Nursing Council believes that registered nurses need to be trained in psychiatric nursing care in clinical and community settings to provide competent care to psychiatric patients. Expanding roles of nurses and advances in technology necessitates additional training to prepare them for effective participation in psychiatric nursing care.

## **2. COURSE DESCRIPTION: MSC PSYCHIATRIC (MENTAL HEALTH) NURSING**

This course is designed to offer advanced education and clinical skills for registered nurses (B.Sc. Nursing & Post Basic B.Sc Nursing) with specialized knowledge and skills in promotive, preventive, curative, and rehabilitative aspects of psychiatric nursing and mental health care, nursing education, administration and research.

### **2.1 Course objectives:**

On Completion of the two year Master of Science in Psychiatric (Mental Health) Nursing, the graduate will be able to:-

- Utilize/apply the concepts, theories and principles of nursing science
- Demonstrate advance competence in practice of psychiatric nursing
- Practice as a psychiatric/mental health nurse specialist.
- Demonstrate leadership qualities and function effectively as nurse educator and manager.
- Demonstrate skill in conducting nursing research, interpreting and utilizing the findings from health related research.
- Demonstrate the ability to plan and effect change in nursing practice and in the health care delivery system.
- Establish collaborative relationship with members of other disciplines
- Demonstrate interest in continued learning for personal and professional advancement.

**2.2 Duration of the course:** Two academic years divided in four semesters. Two semesters each year.

## 2.6 DISSERTATION:

M.Sc. Nursing students shall require to undertake a dissertation on a selected research topic. Chief Guide shall be from the department of Psychiatric Nursing, Co-Guide can be from other related departments.

**SUBMISSION OF THESIS:** Students must submit thesis six months before the 2<sup>nd</sup> year University examination. A candidate who fails to submit thesis within the stipulated time will not be eligible to appear in the final examination.

**NOTE:**

1. Minimum pass marks shall be 50 % in each of the Theory and practical papers separately.
2. A candidate must have minimum of 80% attendance (irrespective of the kind of absence) in theory and practical in each subject for appearing for examination.
3. A candidate must have 100% attendance in each of the practical areas before award of degree
4. A candidate has to pass in theory and practical exam separately in each of the paper.
5. If a candidate fails in either theory or practical paper he/she has to re-appear for both the papers (Theory and practical).
6. Maximum no. of attempts permitted for each paper is 3 including first attempt.
7. The maximum period to complete the course successfully should not exceed 4 (four) years
8. A candidate failing in more than two subjects will not be promoted to the IIInd year.
9. No candidate shall be admitted to the subsequent IIInd year examination unless the candidate has passed the Ist year examination.

## **2.10 CERTIFICATION**

- A Post Graduate degree is awarded upon successful completion of the prescribed study programme which will state that candidate has completed the prescribed course of Master of Science in Psychiatric (Mental Health) Nursing.
- Candidate have had clinical experience at hospital as per INC requirements
- Candidate has passed the prescribed examination

## **2.11 ELIGIBILITY CRITERIA/ ADMISSION REQUIREMENTS FOR M.SC PSYCHIATRIC (MENTAL HEALTH) NURSING**

- i. The candidate should be a Registered Nurse and Registered midwife or equivalent with any State Nursing Registration Council.
- ii. The minimum education requirements shall be the passing of: B.Sc. Nursing / B.Sc. Hons. Nursing / Post Basic B.Sc. Nursing with minimum of 55% aggregate marks from INC recognized Institutes for unreserved category & 5% relaxation SC/ST/OBC\*
- iii. The candidate should have undergone in B.Sc. Nursing / B.Sc. Hons. Nursing / Post Basic B.Sc. Nursing in an institution which is recognized by Indian Nursing Council.
- iv. Minimum one year of work experience after Basic B.Sc. Nursing OR minimum one year of work experience prior or after Post Basic B.Sc. Nursing. (The experience will be calculated up to last date of advertisement). The experience will be counted from the first registration in State Nursing Council.
- v. The candidate shall be medically fit.
- vi. The candidate should have all original educational and experience certificates on the day of counseling.
- vii. The candidate has to submit NOC and relieving order issued from the current employer on the day of counseling (For In Service Candidate)

## **3. COURSE DESCRIPTION: POST BASIC DIPLOMA IN PSYCHIATRIC NURSING**

This course is approved by Delhi Nursing Council and designed to offer advanced education and clinical skills for registered nurses (GNM or B.Sc. nursing) with specialized knowledge and

skills in curative, preventive and promotive aspects of psychiatric nursing and mental health care.

### **3.1 COURSE OBJECTIVES: POST BASIC DIPLOMA IN PSYCHIATRIC NURSING:**

At the end of the course the student will be able to :-

1. Provide quality nursing care to individuals suffering from mental and emotional disorders.
2. Manage and supervise care of mentally ill patients in clinical and community settings.
3. Teach nurses, allied health professionals, family members and communities in areas related to psychiatric nursing.
4. Keep pace with the developments in other related discipline for effective management of psychiatric patients.
5. Conduct research in areas of psychiatric nursing.

**3.2 DURATION OF THE COURSE:** One Academic Year

### **3.3. DISTRIBUTION OF THE COURSE IN WEEKS/HOURS**

### **3.6 RESEARCH PROJECT:**

Candidates have to submit a small research project after community posting. The research project should be carried out under the guidance of a faculty from Dept. of Psychiatry. The research projects should be completed and submitted 2 months before the final examination.

### **3.7 LEAVE:**

Candidates admitted to Diploma in Psychiatric Nursing course will be entitled for 2 weeks leave in the one year of the course.

### **3.8 EXAMINATION SCHEME**

a. The examination will be held at the end of academic year.

b. In each paper 50 marks of internal assessment will be determined on the basis of written/clinical exams, viva voce, supervised clinical work and patient care. These marks will be added to the marks allocated to the respective subject in the yearly final examination. The result of the final examination will be declared on the basis of the total obtained.

c. To become eligible for final examination, a candidate must score a minimum of 50% marks in aggregate of internal assessment.

d. Before appearing final examination, the candidate has to submit a certificate from the DPN In-charge stating that he/she has completed all mandatory requirements including attendance (minimum 75%), essential clinical activities & submitted the research project.

e. The application for appearing at the final examination should be accompanied by a certificate issued by the Head of the Department that the candidate has undergone the course of study and has carried out the clinical work and research assignments as prescribed in the syllabus. Examination form along with requisite fee should be submitted two months before exams.

### **3.9 FINAL EXAMINATION**

The examination will be conducted by Delhi Nursing Council

#### **Qualifying the examination**

a. In order to pass a candidate should obtain at least 50% marks separately in internal

assessment and final examination in each of the theory and practical papers.

- b. Students will be given opportunity of maximum of attempts for passing.

### **Award of Diploma**

Successful candidates shall be classified as under:-

Those who obtain 75% and above	:Distinction
Those who obtain 60% and above and below 75% Those who obtain less than 60%	:1 <sup>st</sup> Division
	:Second Division

- a) Successful candidates shall be awarded Diploma in Psychiatric Nursing by Delhi Nursing Council.
- b) If a candidate fails to pursue course on a continuous basis, or fails or absent himself/herself from appearing in any of the theory and practical exams the merit class shall not be awarded. The merit class (Distinction/First Class) is awarded to those candidates examination in first attempt.
- c) Subject to the provisions of these Regulations, Registrar, Delhi Nursing Council shall publish the result on its receipt from the Head of the Department.

### **3.10 CERTIFICATION**

TITLE – Post Basic Diploma in Psychiatric Nursing

- o A Post Basic Diploma in Psychiatric Nursing certificate is awarded upon successful completion of the prescribed study programme which will state that
- o Candidate has completed the prescribed course of Post Basic Diploma in Psychiatric Nursing
- o Candidate have had clinical experience at hospital as per INC requirements
- o Candidate has passed the prescribed examination successfully.

### **3.11 ELIGIBILITY CRITERIA/ ADMISSION REQUIREMENTS**

A candidate for admission in Post Basic Diploma in Psychiatric Nursing (DPN) should have following qualification :

- a) Be a Registered Nurse (Registered Nurse & Registered Midwife) or equivalent possessing a minimum of one year experience after RN & RM in hospital or educational Institutes.
- b) Nurses from other countries must obtain an equivalent certificate from INC before

admission.

**Distribution of seats: Total DPN seats are 20.**

\*Distribution of seats for reservation is as per guidelines of the Delhi Government

\*Seats remaining vacant in any of the reserve categories shall be filled from the eligible General Category candidates in accordance with prevailing rules on this subject.

**4. ADMISSION PROCESS:**

**a) Number of Seats:**

**M. Sc Psychiatric (Mental Health) Nursing programme: 08 (Eight) seats**

**Post Basic Diploma in Psychiatric Nursing: 20 (twenty) seats**

- b) A candidate who wishes to be enrolled for M Sc Psychiatric (Mental Health) Nursing or Post Basic Diploma in Psychiatric Nursing program shall apply to the Deputy Registrar (Academics) Institute of Human Behavior and Allied Sciences (IHBAS) by the date notified by the Institution/University, on the prescribed form.
- c) The eligible candidates will be allowed to appear in the entrance examination which will be conducted by Delhi University, Delhi. The paper for entrance examination will be of 100 marks and will consist of MCQ type question.
- d) Basis of Selection:  
The selection of the candidates will be done on the merit of entrance examination. All candidates irrespective of reserved or non-reserved category have to appear for the selection test.
- e) Decision of the Admission Committee shall be final.
- f) Selected candidates will have to undergo medical checkup for fitness at IHBAS, New Delhi.
- g) Admission will be confirmed only after making the complete payment of fees for one year and verification of all original certificates, relieving letter/ NOC required for admission.
- h) All admissions are provisional, subject to the verification of original documents and Medical Examination conducted by IHBAS, New Delhi.

**Selection Test:**

- a) Selection test will be held in first week of July 2025. Venue of exam will be made available on IHBAS website as per Delhi University instructions.
- b) The selection test will be of two hours duration. It shall contain multiple choice questions.
- c) The selection test / entrance examination will be based on B.Sc. Nursing/ PB BSc nursing syllabus prescribed by INC for M.Sc. Psychiatric Nursing course.
- d) The selection test / entrance examination will be based on GNM & B.Sc. Nursing/ PB B Sc nursing syllabus prescribed by INC for Post Basic Diploma in Psychiatric Nursing course.
- e) Tie cases will be dealt as per DU guidelines.

## **ADMISSION**

- a. The selection will be made on the basis of merit in the entrance examination.
- b) The minimum cut off marks for admission for both course for various categories will be as follows:
  - a. 50% for candidates belonging to General Category
  - b. 45% for candidates belonging to Physically Handicapped category and
  - c. 40% for candidates belonging to Scheduled Caste category
- c) Merit list of entrance examination will be displayed as per timeline and the candidates will be called for counseling on scheduled day.
- d) Reservation roster will be followed as per applicable

## **5. GENERAL INSTRUCTIONS OF ENTRANCE EXAMINATION FOR ADMISSION:**

1. The examination will be held in first week of July.
2. Timing of the exam will be made available on IHBAS website.
3. No candidate will be allowed to leave the examination hall till the examination formalities are completed.
4. Candidates must carefully read the “Instructions for the candidate” given on the question paper.
5. A merit list will be displayed on IHBAS website/notice board after one week of the entrance examination.
6. Candidates should have obtained at least 50% marks (Gen. Category), 45% (Physically Handicapped category) & 40% (SC/ST) in the entrance test, to be eligible for counseling.
7. Candidate has to submit original certificate at the time of admission in case he/she fail to do so, his/her candidature for admission may straightway be rejected
8. A candidate absent at the time of counseling will not be considered for the admission.
9. No TA/DA will be paid to candidate appearing for entrance exam or documents verification/counseling and joining.
10. If total marks obtained are same by more than one candidate, candidate senior in age will be considered.
11. The selected candidate will have to undergo medical fitness test & only those candidates who are found medically fit by the constituted Medical Board will be admitted to the course.
12. The Post Basic Diploma in Psychiatric Nursing students shall receive a monthly stipend of Rs.2000/- except for in-service candidates.
13. The M.Sc. in Psychiatric (Mental Health) Nursing students shall receive a monthly stipend of Rs.15000/- except for in-service candidates.

## **6. HOSTEL FACILITIES:**

Hostel facilities are available for the students in the campus, subject to availability at the time of admission.

## **7. COURSE FEES:**

A candidate for the Post Basic Diploma in Psychiatric Nursing course shall pay a fee and other charges for academic year as prescribed by the Delhi Nursing Council.

M.Sc. in Psychiatric (Mental Health) Nursing course shall pay a fee and other charges for academic year as prescribed by the University of Delhi time to time. The fee and other charges shall be paid before joining the course. Candidate will pay the examination fee to Delhi University/ DNC/ IHBAS.

The course fee should be submitted in the form of Demand Draft in Favour of '**The Director, IHBAS, Delhi**'.
