- The quotation may be dropped in the Tender Box available in Purchase Section, IHBAS, or sent by speed post by 2:00 p.m. on or before 21.10.2021. Quotation received after last date will neither be entertained nor returned. Quotation received will be opened on the same day at 2:30 p.m. in the presence of the bidders or their authorized representative, if any.
- Rate Contract will be for 2 years from the date of opening of tender. However, the rates can 2. be extended for another one year on mutual consent if needed
- The bidder will quote the price for all 5 items as mentioned above. Price of selective item 3. will not be considered for evaluation of ranking.
- L-1 will be decided on the basket total price after taking into consideration the price of one 4. item of 5 rubber stamps/name plates as mentioned above.
- The approved agency will be emailed for making the rubber stamp and name plates required 5. from time to time by MRO, IHBAS.
- The approved agency will physically deliver the stamp/name plate, as the case may be in 6. good condition within 2-3 days positively to MRO, IHBAS.
- The approved agency will be bound to make and supply of even one stamp/name plate under 7. Rate Contract. They will have no right for minimum and maximum number of rubber stamp/name plates for issue of order under Rate Contract.
- The approved agency will have no right for any order for rubber stamps/name plates during 8. the Rate Contract. Order will be placed strictly based on the need of the Institute.
- Payment will be made on monthly basis after completion of the calendar month and on the 9. receipt of the bill in respect of rubber stamp/name plates made during one month and received in good condition.
- The payment will be made through ECS/RTGS after certifying by MRO, IHBAS that 10. stamp/name plates has been made in accordance with the required specification, and received in good condition.
- All bidders have to submit their ECS/RTGS details along with the tender. 11.
- No payment shall be made in respect of rejected items. 12.
- Force Majure will be accepted on adequate proof thereof. In this regard, the decision of the 13. Director, IHBAS will be final and binding on the supplier.
- Quotations not adhering to the above requirements will be rejected at the discretion of the 14. Director, IHBAS.
- The tender form is NOT TRANSFERABLE. 15.
- Tenderer submitting tender would be deemed to have considered and accepted all the terms 16. and conditions. No enquiries, verbal or written shall be entertained in respect of acceptance or rejection of the tender.
- The Director, IHBAS, reserves the right to reject any tender at any stage without assigning 17. any reason therefore. No correspondence whatsoever shall be entertained in this regard as the decision of Director, IHBAS, is final and binding.

In case breach of the contract during the execution of the Rate Contract, the agency will be debarred and blacklisted by the Institute. The decision of the Director, IHBAS will be final and binding on the agency.
